## INTRODUCTION

The MINI Charging rates are governed by the maximum charging speed.

MINI Charging differentiates the following charging speeds:

AC – alternating current (normal charging)

DC – direct current (fast charging)

HPC – high power charging (ultra-fast charging)

The maximum charging power capacity of each charging station can be found on the MINI Charging website and the MINI app.

Please note that the transaction units for charging in public areas may vary due to regulatory requirements in the individual European countries. A transaction is differentiated in terms of kWh, time (min.), or by charging event. All prices are individually based on charge point operators. A variable tariff applies with regard to the individual charging process. The prices depend on respective charge point operators. For charging abroad (= e-roaming), you will always pay the local sales rate without any additional fees.

## CHARGING EVENT TRANSACTION

The invoicing of varying fees for charging is based on the appropriate tariff per minute (per commenced minute), per kWh or per charging event. The charging event starts if the vehicle is connected to the charging station and ends when it is disconnected. You can also recharge for free using the MINI Charging service at free charging stations.
